

Logging in to Finavia's Airportal and AOS systems will become smoother and easier for those working at airports. Activate the electronic Finavia identity sent to your email in accordance with these instructions. Please note that the invitation has been sent to those who have an email address in the FinaviaPass system.

How to activate a Finavia visitor user ID

The activation of the user ID is divided into two stages: activation and authentication. Follow the step-bystep instructions. In case of problems, please contact:

1. Activating the Finavia visitor user ID

A. First, you will receive an email from Microsoft's service, which you must accept via the Accept Invitation link in order to activate the Finavia visitor user ID created for you.

 - o your password is the password for your organisation's username



- **b.** If your organisation does not provide a work email address and you are asked for a password,
 - your password is the password of the Microsoft account linked to the email address (not the inbox password)
 - c. Otherwise, a one-time passcode will be sent to your inbox from Microsoft's service

2. Setting up multi-factor authentication (MFA)

After activation, you must authenticate yourself. Multi-factor authentication has been made mandatory in order to protect Finavia's visitor user IDs.
